ARTICULATION AGREEMENT

between

Kansas Wesleyan University

and

Johnson County Community College

This articulation agreement (the "Agreement") is entered into between Johnson County Community College and Kansas Wesleyan University. This Agreement incorporates by reference the "4-Year Institution Recruiting Access and Accountability Agreement" executed by Kansas Wesleyan on February 4, 2014 (and as renewed in subsequent years), which terms and conditions shall remain in full force and effect during the term of this Agreement.

Kansas Wesleyan University assures the acceptance of any Johnson County Community College Associate of Arts (AA) and Associate of Science (AS) graduate as a baccalaureate degree-seeking student with junior standing. Further, Kansas Wesleyan assures Johnson County Community College graduates their credits will transfer as a block to cover needed general education requirements at Kansas Wesleyan. When a Johnson County Community College student applies for admission, Kansas Wesleyan will analyze her/his transcript and create an individualized academic work report detailing all equivalencies.

Kansas Wesleyan University will honor the policy of the Kansas Board of Regents to facilitate the ease of transition of students from in-state community college to four-year institutions. Although the following distribution of courses does not necessarily correspond to the general education requirements for the bachelor degree from Kansas Wesleyan University, it shall be accepted as having satisfied the general education requirements for the Kansas Wesleyan University bachelor degree.

A minimum of 45 credit hours of general education with distribution in the following fields shall be required. General education hours totaling less than 45 shall be accepted, but transfer students must complete the remainder of the below requirements before graduation from Kansas Wesleyan University, which may require an additional semester(s). Under this agreement the following are required:

- Johnson County Community College students must graduate with an Associate of Arts (A.A.) degree or Associate of Science (AS) and with a GPA of at least a 2.0, and
- Johnson County Community College students must complete a minimum of **45 hours** of liberal studies with distribution in the following areas:
 - **12 hours** of Basic Skills courses: **6 hours** of English composition, **3 hours** of Speech Communication, and **3 hours** of College-level Mathematics.
 - **12** hours of Humanities courses from at least three of the following disciplines: Art, Theatre, Philosophy, Music, History, or Literature (Note: performance courses are excluded).
 - **6 hours** of Social and Behavioral Science courses from at least two of the following disciplines: Sociology, Psychology, Political Science, Economic, Geography, or Anthropology.
 - **6 hours** of Natural and Physical Science courses from at least two disciplines (lecture with lab).
 - **9 hours** of electives from the areas of Humanities, Social and Behavioral Science, or Natural and Physical Science.

Interested Students should note:

1. All graduates of Kansas Wesleyan University are required to take a 3 hour Bible course.

- 2. To graduate from Kansas Wesleyan, transfer students must meet all other prerequisite, program, degree, and residency requirements as described in the KWU Academic Catalog.
- 3. Students with other degrees from Johnson County Community College are not addressed in this Agreement. KWU welcomes those students, but will assess their transcripts on an individual basis.
- 4. Johnson County Community College students will receive full consideration for all forms of federal, state, and institutional financial aid, based on results of their Free Application for Federal Student Aid (FAFSA) data and their cumulative Johnson County Community College GPA. Transfer students will also be eligible for housing in KWU dorms, and other student services, such as academic advising and the Student Success Center.

Johnson County Community College and Kansas Wesleyan University may include information about this Agreement in their online or other appropriate college publications.

Kansas Wesleyan shall not use the name, trade name, trademark or any other designation of JCCC, or any contraction, abbreviation, adaptation or simulation of any of the foregoing, in any advertisement or for any commercial or promotional purpose (other than in performing under this Agreement) without JCCC's prior written consent in each case.

To the extent permitted by law, each party shall indemnify and hold the other party (and its employees, directors, trustees and agents) harmless for any action or omissions on the part of its employees, directors, trustees or agents.

This Agreement shall be governed by the laws of the State of Kansas. This Agreement shall not become effective until approved by the JCCC Board of Trustees (anticipated in June 2014).

This Agreement may be terminated by either party with written notice of at least one year, and in such case, any JCCC students who have already been advised with respect to the courses that would transfer to Kansas Wesleyan will be permitted to transfer such courses as set forth in the advisory materials.
