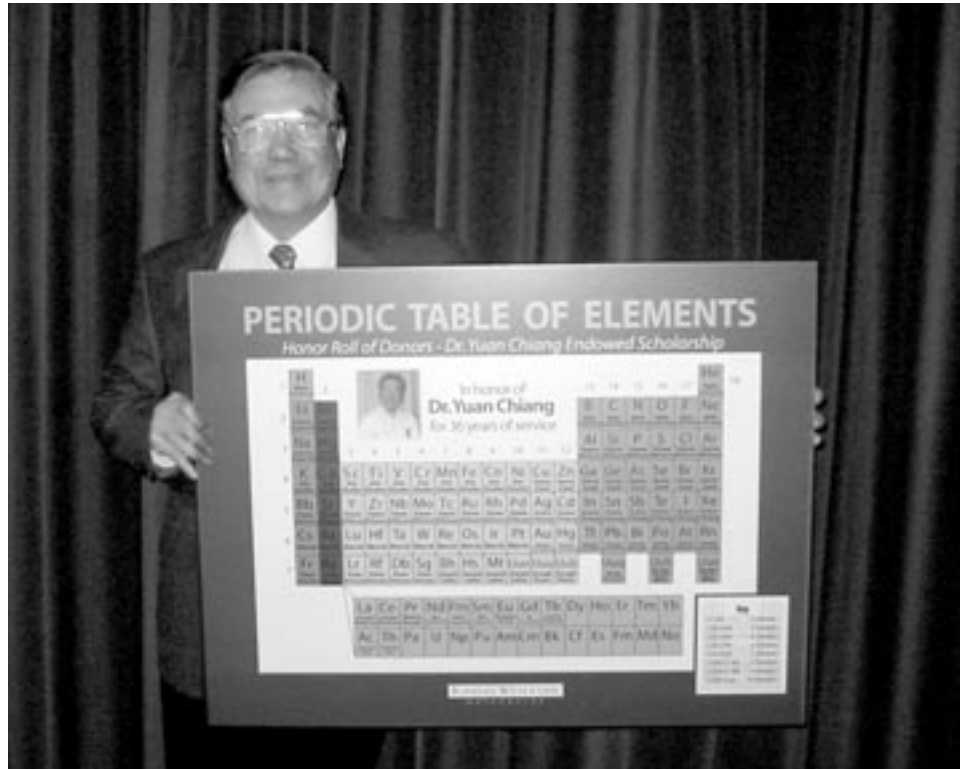


Dr. Yuan Chiang Endowed Scholarship Fund created at KWU

Endowed scholarships make private education possible for many students

Endowment is the lifeblood of all institutions of higher education. A vital component of KWU's endowment is those funds dedicated to providing scholarship monies to KWU students. These endowed scholarships make the opportunity of a private education a reality for all students.

The attractiveness of endowed scholarships is that they can be easily tailored

to the desires of the donor. Donors have the ability to name the scholarship and establish criteria for the scholarship recipients. Often, scholarships are named after the family of the donor, a business, or in honor of an individual who had/has a relationship with KWU. The name of the scholarship will be honored in perpetuity at KWU as it will provide a scholarship for deserving students annually. Criteria are often selected by the

Bradley's provide funds for rejuvenation of tennis courts

The tennis courts at Kansas Wesleyan University are alive and well thanks to a donation from KWU alumni Dale and Susanne Bradley. The courts, located just north of the KWU Fieldhouse, were dedicated in honor of the Bradley's during a special ribbon-cutting ceremony Sept. 26.

Dale Bradley is a 1959 graduate of KWU and is a member of the Board of Trustees. His wife, Susanne (Ayres) Bradley, also attended Kansas Wesleyan and they made the refurbishing of the tennis courts possible through a monetary gift to the university.

"We are happy to see the remodeling of the courts at KWU, not only for KWU athletics, but for the general public in and around Salina as well. It is our sincere hope that now that we have a good facility, it will remain in good shape for many years to come," he said.

Although not a tennis player as a student, Bradley played varsity basketball, football and track. "As an athlete, I was allowed to compete in three major sports while still getting a fine education," he said. "This could not have been accomplished in a larger school. I love sports, and was never turned down by any coach if I wanted to participate in their sport."

Bradley said KWU is now better prepared to recruit students who love the game of tennis. "Tennis is a super recruitment

"Susanne and I have been devoted to KWU through the many years since our attendance here. We continue to encourage others who have received multiple benefits from the university to support this institution to the best of their ability and resources," he said.

KWU experience that most affected the donor or honoree. Popular criteria include GPA, campus involvement (such as music), and/or area of study.

An excellent example of the endowed scholarship was the recent creation of the Dr. Yuan Chiang Endowed Scholarship. Former students of chemistry professor Dr. Chiang were consulted to determine a fitting remembrance for his 36 years of service to KWU. It was decided that an endowed scholarship - created in his name and to be given to future chemistry

students - would establish a lasting legacy for Dr. Chiang. The scholarship was officially announced and presented in Dr. Chiang's honor during Homecoming 2002.

The Dr. Chiang scholarship, along with the many other scholarships that are primarily funded by one donor, will not only award scholarships every year but will also remain open for future gifts. Scholarship contacts appointed by the donor will also receive yearly correspondence detailing the fund balance and scholarship recipients.

Endowed scholarships require a

minimum balance of \$5,000 and can be created with cash or a variety of assets. Also, endowments can be created through an outright gift, a multi-year pledge, or through estate planning instruments such as bequests and charitable trusts. An income of 4.5% of the fund balance will be distributed annually as the scholarship amount.
