☐ **PARENT (PLUS) LOAN**—Credit-based loan available to a parent/step-parent of a dependent student at [studentaid.gov](#). Parent should sign in with their FSA ID and password to "Apply for a PLUS Loan" and "Complete Loan Agreement for a [PLUS Loan \(MPN\)](#)". Parent PLUS loan applications for the award year 2026-27 are typically available around April 15, 2026. ***Note:** There is a 4.228% origination fee that will be charged during disbursement. Please request enough to cover this charge in addition to the expected student account balance. Example: if \$10,000 is requested, there will be a \$423.00 fee and \$9,577.00 will be applied to the student's account. ☐ **ALTERNATE EDUCATIONAL PRIVATE LOAN**—Credit-based loans for students, deferred for half time or greater, and a six-month grace period after school before repayment begins. **Apply for the entire year; funds are disbursed each semester.** A co-signer is recommended/required for freshmen or students with no/low credit scores. Interest rate is based upon credit and determined by the lender selected. Applications can be completed after April 15, 2026. KWU does not endorse any particular lender; however, we do provide a resource called [FastChoice](#) to help you decide which lender is the best fit for you.
