**PARENT (PLUS) LOAN**—Credit-based loan available to a parent of a dependent student at <u>studentaid.gov</u>. Parent should sign in with their FSA ID and password to "Apply for a PLUS Loan" and "Complete Loan Agreement for a PLUS Loan (MPN)". Parent PLUS loan applications for the award year 2024-25 <u>are typically available around April 30, 2024</u>. Note: There is a 4.228% origination fee that will be charged during disbursement. Please request enough to cover this charge in addition to the expected student account balance. Example: if \$10,000 is requested, there will be a \$423.00 fee and \$9577.00 will be applied to the student's account. <u>ALTERNATE EDUCATIONAL PRIVATE LOAN</u>—Credit-based loans for students, deferred for half time or greater, and a six-month grace period after school before repayment begins. Apply for the entire year; funds are disbursed each semester. A co-signer is recommended, required for freshmen or students with no/low credit scores. Interest rate is based upon credit and determined by the lender selected. Applications can be completed after April 15, 2024. KWU does not endorse any particular lender; however, we do provide a resource called <u>FastChoice</u> to help you decide which lender is the best fit for you. \*<u>LUMP-SUM PAYMENT</u>—A single, one-time payment made before any of the above three options. This one-time payment can be made before both semesters or one academic semester. Billing is charged to students each semester beginning in August and January.
