Throughout the duration of the candidate's clinical practice experience, the cooperating teacher and the university supervisor will each complete a formative evaluation a total of four times, as well as a summative evaluation two times, throughout the sixteen weeks that the prospective teacher is with them in the classroom. Content area faculty will observe and evaluate the candidate twice during the sixteen weeks of evaluation, once in the first eight weeks and once in the second eight weeks. All supervising faculty will submit their formative evaluations every four weeks and the summative evaluations will be submitted every eight weeks to provide a complete overview of the candidate's growth.

Early field experiences have been intentionally assigned giving students experience in schools with varying demographics and socioeconomic statuses. These placements begin with the History and Foundations of Education and continue throughout the education program. Differentiated instruction is stressed in all methods courses along with the curriculum modification for a variety of learning disabilities. The content of courses such as Classroom Management, Instructional Technology, and all methods courses are evaluated and updated regularly to ensure alignment with current research-based strategies. All students are required to take the course "Educating the Exceptional Individual" exposing them to the needs of students with exceptionalities and the responsibilities of all teachers in meeting those needs. Candidates seeking special education endorsement complete the elementary or secondary requirements of Kansas Wesleyan University (KWU) and take the special education requirements of the Kansas Independent

All pre-service teachers must satisfactorily complete a course titled Instructional Technology. In this course they learn the various applications of technology within the lessons taught in the classroom. Pre-service teachers develop and deliver lessons that incorporate technology. They also learn to evaluate technology applications in relation to instructional goals. They learn what technology applications are appropriate for the different portions of a lesson, classroom management, and teacher efficiency. They teach multiple lessons that incorporate instructional technology while taking the class. Throughout early field experience, students are evaluated on the use of technology and instructional aids. When in clinical practice, candidates are evaluated on their use of technology during instruction by their cooperating teacher and university supervisor (a total of eight times).

## Teacher Training

### 1. Provide a description of the activities that prepare general education teachers to:

#### a. Teach students with disabilities effectively

All students are required to take the Education of the Exceptional Individual. Pre-service teachers are taught about various exceptionalities they may encounter in the general education classroom. This course includes a study of exceptionalities ranging from severe multiple disabilities to gifted. Emphasis is placed on the development of skills necessary to work with exceptional children in the regular classroom. All students spend 10 hours in a PK-12 SPED classroom during this course. They are introduced to various strategies and assistive technologies that could be used to provide support to students with disabilities. They must determine which strategies and assistive technology would be used in enhancing the education of students with disabilities. They are prepared, through the use of differentiated instruction and other strategies, to meet the learning needs of all students.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Clinical practice candidates work with their cooperating teachers to develop lessons that specifically address the needs of the diverse populations in the classrooms. This includes any students who have an IEP. Education students learn to recognize the parts of an IEP and the terminology that is often used. They become aware that the general education teacher must carry out an IEP and document the student's progress. They also learn that as the general education classroom teacher they have the initial role in recognizing a student who falls below the norm and must initiate a student intervention plan. As part of their clinical practice they are responsible for implementing any IEPs in the classroom. The Kansas Teacher Work Sample requires that our pre-service teachers develop a plan to address the diverse learning needs of a subgroup; many times the subgroup addressed includes students with an IEP.

#### c. Effectively teach students who are limited English proficient.

Education students are provided with strategies to equip them to work with English Language Learners. Strategies for English Language Learners are taught in both Methods of Teaching Reading and Language Arts for the Beginning Reader and the Developing Reader. Field experience is required in which students work with varying abilities and who are limited English proficient. During their clinical practice, the student teachers work in a school district that has a population of English Language Learners. Through this experience, they observe classroom interaction among teachers, students new to the United States, and students whose first language is not English. The Kansas Teacher Work Sample requires that our pre-service teachers develop a plan to address the diverse learning needs of a subgroup which may include students who are limited English proficient.

#### a. Teach students with disabilities effectively

All education students are taught strategies to provide differentiation in the general education classroom. Those students that want an endorsement in Special Education must also obtain or hold an elementary or secondary license. The requirements for the SPED endorsement are taught through the Kansas Independent Colleges Association (KICA). The KICA provides undergraduate endorsement coursework that includes field experiences for three of the four courses and has developed an assessment system that is aligned with its conceptual framework. KICA has a fully accredited program which includes the following: assessment of the student's ability to plan instruction, assessment of clinical experience, assessment of candidate's effect on student learning, philosophical, historical, legal foundations, managing behavior, problem-solving, and social skills.

**b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.**

KICA prepares candidates to teach in special education classrooms. Coursework assignments include observations of the development of an IEP, observations of an IEP team meeting, IEP videos/simulations, planning of an IEP based on a case study, and preparation of an IEP during the clinical practice SPED placement.

**c. Effectively teach students who are limited English proficient.**

KICA also prepares candidates to work with diverse populations, including English Language Learners. Coursework includes diversity interviews, diversity issues in assessment, diversity reference materials, and reading programs for English Language Learners.

Kansas Wesleyan University (KWU) is located in Salina, a central Kansas community with a population of about 47,000. KWU is a small university, grounded in the liberal arts tradition. The University is accredited by the North Central Association of Colleges and Schools-Higher Learning Commission (NCA-HLC). In spring 2017, the University completed a successful Higher Learning Commission regional accreditation visit, with recommendations for continued accreditation for a 10-year period with no required interim follow-up visits or reports. The Teacher Education Program is accredited by the Kansas Board of Education (since 1947) and the National Council for Accreditation of Teacher Education (since 2002). It is the philosophy of the Teacher Education Program that a liberal arts education coupled with an academic major and professional teacher training produces an effective P-12 teacher. The Conceptual Framework of the program states: "Kansas Wesleyan University prepares reflective teachers with the potential for professional leadership who demonstrate academic and professional excellence, have sound personal qualities, have a commitment to education and life-long learning, demonstrate world citizenship and are committed to faith." KWU currently offers 4 academic programs that lead to teacher licensure with additional endorsements available in SPED. Two important groups provide oversight for the Teacher Education Program—the Teacher Education Unit Committee and the Teacher Education Advisory Council. Each group has a different representation and provides a specific function in the program. The Teacher Education Department Unit Committee is comprised of faculty from the academic programs that lead to licensure. The Teacher Education Department/Unit committee oversees curriculum, assessments, and procedures in teacher education. The committee makes decisions regarding the acceptance of students into the program and clinical practice. The committee also decides on probation within or dismissal from the program and hears appeals made to the Teacher Education Program. The Teacher Education Advisory Council is comprised of teachers and administrators in the field, graduates of the program, faculty, community members, and two candidates who are fully accepted into the teacher education program. This Council makes recommendations regarding program evaluations, follow-up surveys, early field experiences, and provides a link to the educational community in Salina and surrounding areas. A testimony to the success of KWU's teacher education program is the number of teachers employed by USD 305, Salina. These graduates are contributing to the quality of the Salina schools.
