**PAYMENT IN FULL BEFORE AUGUST 1 (fall semester) and JANUARY 1 (spring semester)**

**AUTOMATIC BANK DRAFT**—I authorize Kansas Wesleyan University to deduct payments for my student's educational charges from my account listed below. I understand the monthly payments will equal approximately one quarter of the total per term. I understand the ACH withdrawals will occur on Aug. 1, Sept. 1, Oct., 1. And Nov. 1, for Fall 2022. Jan. 1, Feb. 1, March 1, and April 1 for Spring 2023. The automatic bank draft fee is \$30 per semester. Enrollment in the bank draft program after the first draft date will require the total of the missed drafts to be paid in full prior to acceptance of ACH enrollment by KWU.

**PARENT (PLUS) LOAN**—Credit-based loan available to a parent of a dependent student at [studentaid.gov](http://studentaid.gov). Parent should sign in with their FSA ID and password to "Apply for a PLUS Loan" and "Complete Loan Agreement for a PLUS Loan (MPN)". Parent PLUS loan applications for the award year 2022-23 can't be completed until after April 20, 2022. Note: There is a 4.228% origination fee that will be charged during disbursement. Please request enough to cover this charge in addition to the expected student account balance. Example: if \$10,000 is requested, there will be a \$423.00 fee and \$9577.00 will be applied to the student's account. **ALTERNATE EDUCATIONAL PRIVATE LOAN**—Credit-based loans for students, deferred for half time or greater, and a six-month grace period after school before repayment begins. **Apply for the entire year; funds are disbursed each semester.** A co-signer is recommended, required for freshmen or students with no/low credit scores. Interest rate is based upon credit and determined by the lender selected. Applications can be completed after April 1<sup>st</sup>.
